## II. FRAMEWORK FOR MAKING AND ENFORCING POLICIES

### 1. Structure and Powers of the Government/Authority of Sub-Central Governments/Uniform Administration (to be notified to the General Council)

#### (a) revision or enactment of domestic laws, regulations and other measures related to China's commitments under the WTO Agreement and Protocol, including those of local governments at the sub-national level, that have been promulgated since accession or the previous meeting of the relevant body under the Transitional Review Mechanism

Since last transitional review, China has enacted or revised the following laws and administrative regulations in accordance with its WTO commitments:

1. *Securities Law of the People's Republic of China (revised)* ( published on 27 Oct 2005, to come into effect on 1 Jan 2006;
2. *Company Law of the People's Republic of China (revised)* ( published on 27 Oct, 2005, to come into effect on 1 Jan 2006;
3. *Regulations on Administration of Direct Sales* (published on 23 Aug 2005 to be implemented since 1 Dec 2005;
4. *Regulations on Prohibition of Multi-level Marketing* (published on 23 Aug 2005, to be implemented since 1 Nov 2005;
5. *Implementing Regulations of the Law of People's Republic of China on Import & Export Commodity Inspection* ( published on 31 Aug 2005 to be implemented since 1 Dec 2005.

#### (b) establishment and operation (upon accession) of the mechanism pursuant to Section 2(A), paragraph 4 of the Protocol under which individuals and enterprises can bring cases of non-uniform application of the trade regime to the attention of national authorities

Pursuant to Legislation Law of the People's Republic of China Regulations on Procedures for the Formulation of Rules, and the Regulations on Record-keeping of Regulations and Rules, any state administrations, social groups, enterprises and individuals, who believe that any provisions in regulations, departmental rules and administrative measures are inconsistent with the ones contained in those at an upper level, can put forward review suggestions in written form to the Legislative Affairs Office of the State Council. At present, people's governments of provinces, autonomous regions, municipalities directly under the central government all have stipulations on the submission of review suggestions in written form to local people's governments at different levels by state administrations, social groups, enterprises and individuals and on the process of dealing with review suggestions in written form by legislative institutions of the government within the record-keeping system of regulative documents.

From 1 Nov 2004 to 31 Oct 2005, Legislative Affairs Office of the State Council received 59 cases of review suggestions in written form from state administrations, social groups, enterprises and individuals, of which there was no review suggestion in written form related to China's foreign trade legislation regime.
