II. FRAMEWORK FOR MAKING AND ENFORCING POLICIES

- 1. Structure and Powers of the Government/Authority of Sub-Central Governments/Uniform Administration (to be notified to the General Council)
- (a) Revision or enactment of domestic laws, regulations and other measures related to China's commitments under the WTO Agreement and Protocol, including those of local governments at the sub-national level, that have been promulgated since accession or the previous meeting of the relevant body under the Transitional Review Mechanism

Since last transitional review, China has enacted or revised the following laws and administrative regulations at the central level, which may be related to its WTO commitments:

- 1. Patent Law of the People's Republic of China (Revised) Adopted on 12 March 1984; amended on 27 December 2008 and entered into force as of 1 October 2009
- 2. Insurance Law of the People's Republic of China (Revised) Adopted on 30 June 1995; amended on 28 Feb 2009 and entered into force as of 1 October 2009
- 3. Postal Law of the People's Republic of China (Revised) Adopted on 2 December 1986; amended on 24 April 2009 and entered into force as of 1 October 2009
- 4. Frontier Health and Quarantine Law of the People's Republic of China (Revised) Adopted on 2 December 1986; amended and entered into force on 27 August 2009
- 5. Law of the People's Republic of China on the Entry and Exit Animal and Plant Quarantine (Revised) Adopted on 30 October 1991; amended and entered into force on 27 August 2009)
- 6. Regulation on Travel Agencies Promulgated on 20 February 2009 and entered into force as of 1 May 2009.
- (b) Establishment and operation (upon accession) of the mechanism pursuant to Section 2(A), paragraph 4 of the Protocol under which individuals and enterprises can bring cases of non-uniform application of the trade regime to the attention of national authorities

Pursuant to the Legislation Law of the People's Republic of China, Regulations on Procedures for the Formulation of Administrative Regulations, Regulations on Procedures for the formulation of Rules and Regulations on Record-keeping of Regulations and Rules, where any state organ, social group, enterprise and institution and citizen who believes that local regulations, rules and other policies and measures promulgated by organs with the power to formulate rules contravenes those at an upper level, or there are differences among them, may submit a written proposal to the Legislative Affairs Office of the State Council for review.

From 1 November 2008 to 31 October 2009, the Legislative Affairs Office of the State Council received 86 written proposals for review from related state organs, social groups, enterprises and institutions and citizens, among which 1 was submitted by a state organ, and 12 were submitted by social groups, enterprises and institutions and 73 by citizens. The Legislative Affairs Office of the State Council has dealt with these proposals according to the prescribed procedures.
