TRANSITION REVIEW MECHANISM IN CONNECTION WITH PARAGRAPH 18 OF THE PROTOCOL ON THE ACCESSION OF THE PEOPLE'S REPUBLIC OF CHINA

Submission by the Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu

1. Chinese Taipei welcomes the efforts made by China to bring its technical regulations, standards and conformity assessment procedures into compliance with the Agreement on Technical Barriers to Trade. China's statement in accordance with Article 15.2 (G/TBT/2/Add.65) provides useful information regarding the measures taken to ensure the implementation of the TBT Agreement. However, Chinese Taipei not only wishes to associate itself with the same concerns as expressed by Japan and the European Communities, but in addition we also have the following specific questions for China in the areas of standards and conformity assessment.

I. STANDARDS

2. In paragraph 180 of the report of the Working Party, China has committed itself to speed up the process of revising its current voluntary national, local and sectoral standards in order to harmonize them with international standards. What progress has China made in this respect and exactly what revisions have been made to date.

II. CONFORMITY ASSESSMENT

Paragraph 13, 4(b) of China's Accession Protocol stated, "No later than 18 months after accession, China shall assign the respective responsibilities of its conformity assessment bodies solely on the basis of the scope of work and type of product without any consideration of the origin of a product. The respective responsibilities that will be assigned to China's conformity assessment bodies will be notified to the TBT Committee 12 months after accession." Chinese Taipei would like to know what progress China has made to date on the assignment of these responsibilities.
- 4. Chinese Taipei would appreciate knowing what measures have been taken by China to ensure compliance by its local government bodies with the provision of Article 7.1 of the TBT Agreement.
- 5. While China has committed itself to apply the same conformity assessment procedures to both imported and domestic products, Chinese Taipei would like to know whether results of the conformity assessments or certificates are mutually recognized by provincial conformity assessment bodies or authorities. Can China give assurances that products will not be required to be tested again on their movement within China from one province to another?
- 6. In paragraph 16 of China's statement on Implementation and Administration of the TBT Agreement, both the State General Administration of the People's Republic of China for Quality Supervision and Inspection and Quarantine (AQSIQ) and the China National Regulatory Commission for Certification and Accreditation (CNCA) are the authorities to adopt and promulgate conformity assessment procedures. Chinese Taipei would like to know what are the respective responsibilities of the AQSIQ and CNCA and what are the procedures required for local and foreign certification bodies to participate in the conformity assessment process.
