## **UNITED STATES – SUBSIDIES ON UPLAND COTTON**

## Communication from Brazil

The following communication, dated 8 March 2010, from the delegation of Brazil to the Chairman of the Dispute Settlement Body, is circulated at the request of that delegation.

On 19 November 2009, the Dispute Settlement Body ("DSB") authorized Brazil to suspend the application to the United States of concessions or other obligations consistent with the Arbitrator's Decision contained in document WT/DS267/ARB/1. On the same date, the DSB also authorized Brazil to suspend the application to the United States of concessions or other obligations consistent with the Arbitrator's Decision contained in document WT/DS267/ARB/2 and Corr.1.

The authorizations were granted pursuant to Brazil's requests contained in documents WT/DS267/41 and WT/DS267/42. In both requests, Brazil undertook to notify the DSB of the countermeasures it intended to adopt prior to bringing them into force.

Application of the methodology established by the Arbitrator in paragraph 6.5(a) of the Decision contained in document WT/DS267/ARB/1, using data from the most recent period for which complete data are available (fiscal year 2008 and calendar year 2008), yields an annual level of countermeasures of US\$ 682 million. Adding this value to the annual fixed level of countermeasures of US\$ 147.3 million that arises from the Decision contained in document WT/DS267/ARB/2 and Corr.1, results in a total annual level of countermeasures of US\$ 829.3 million.

On the basis of the same period, the threshold described in paragraph 5.201 of the Decision contained in document WT/DS267/ARB/1, as well as in paragraph 5.201 of the Decision contained in document WT/DS267/ARB/2 and Corr.1, updated to account for the change in Brazil's total imports from the United States, is US\$ 561 million.

Paragraph 6.5(b) of the Decision contained in document WT/DS267/ARB/1 reads as follows:

"In the event that the total level of countermeasures that Brazil would be entitled to in a given year [footnote] should increase to a level that would exceed the threshold described in paragraph 5.201, updated to account for the change in Brazil's total imports from the United States, then, Brazil would also be entitled to seek to suspend certain obligations under the TRIPS Agreement and/or the GATS, as identified in footnote 468, with respect to any amount of permissible countermeasures applied in excess of that figure." [Text of footnote]: "It is understood that this amount is to be calculated taking into account the entirety of the level of countermeasures that Brazil is entitled to at that point in time, arising both from the application of the formula identified in paragraph 6.5(a) and from the Decision by the Arbitrator contained in WT/DS267/ARB/2." But for the cross-references, the text of paragraph 6.5(b) of the Decision contained in document WT/DS267/ARB/2 and Corr.1 is identical.

In light of the above, starting from 7 April 2010, Brazil will suspend the application to the United States of concessions or other obligations under the *General Agreement on Tariffs and Trade 1994* (GATT 1994) in the form of increased import duties on certain products when they are imported from the United States. The products that will be subject to the increased duties, together with the total rate of *ad valorem* duty that will be applied as a result of the increase, are listed in the Annex. This suspension corresponds, over one year, to a total value of approximately US\$ 591 million. Should there be any changes to the above-mentioned countermeasures during the period of their application, Brazil will notify the DSB before the changes come into effect.

Since the total annual level of countermeasures to which Brazil is currently entitled exceeds the threshold identified above, Brazil will also suspend the application to the United States of certain concessions or obligations under the *Agreement on Trade-Related Aspects of Intellectual Property Rights* ("TRIPS Agreement") and/or the *General Agreement on Trade in Services* (GATS), up to an annual amount of approximately US\$ 238 million. Brazil will notify to the DSB the specific concessions or obligations under TRIPS and/or GATS whose application to the United States will be suspended before such suspension comes into force.
