**SHARES OF WTO MEMBERS IN
WORLD NON-AGRICULTURAL TRADE, 1999-2004**

Note by the Secretariat¹

In response to a request by Members at consultations held on 11 November 2005, the Secretariat has prepared tables which show the shares of WTO Members in world non-agricultural trade from 1999 to 2004. Tables 1, 2 and 3 show the shares of WTO Members in world non-agricultural exports, imports and total trade (exports + imports), respectively. Average shares for the periods 1999-2004, 1999-2001 and 2002-2004 are also shown.

All data for individual economies were extracted from the UN Comtrade database on 1 November 2005. These data are based on national submissions. Figures for the European Communities refer to the extra-trade of its 25 member States.

World exports excluding significant re-exports were taken from the Secretariat's International Trade Statistics Report 2005. The figures were also used to derive import shares.
